### Optional Federal Tort Claims Act (FTCA) Gap Coverage

For federally funded clinics, the program offers optional FTCA gap coverage. Although these clinics are covered by the FTCA, federal regulators may reject claims, leaving clinics potentially exposed to major liability risks. Our program's gap coverage provides medical professional liability coverage for claims, up to the policy limits (subject to policy terms and provisions), for those claims that are excluded under the FTCA. Gap coverage also offers assistance to the clinic by helping to submit FTCA claims to the government, and provides defense representation and payment of associated costs while the claim is being evaluated. The program is appropriately discounted for clinics covered by the FTCA.

### Information and Network Security Insurance

Information and network security coverage is available to all CHCP policyholders, at no additional premium cost and with no deductible, which protects against a wide variety of potential costs related to information security. Information and Network Security Insurance covers your clinic for claims alleging unauthorized release of personal information; protection from material published on a website, in ads or other media; costs associated with the defense of HIPAA violations; expenses resulting from information breaches; and expenses for recovering lost electronic data caused by a computer virus, hacking or other breach.
